Nothing in this disclaimer is intended to release any party mentioned herein for any liability for injury or death caused through that party's negligence.

By signing this Release, I certify that I have read this Release and fully understand it and that I am not relying on any statements or representations made by the "RELEASED PARTIES".

All members of III Rivers UK Chapter must be members of H.O.G. before they can bring a guest to any chapter event.

All members of III Rivers UK Chapter are welcome, and encouraged to bring guests to our chapter events.

III Rivers UK CHAPTER run 3 types of events:

1. Open Event – Where members can bring unlimited guests.
2. Closed Event – Where members can bring one guest, and direct family members such as partners/spouses and children. Please Note: Children may be excluded from certain age restricted events.
3. Members Only Event – Guests are not allowed.

All members are allowed to bring guests to III Rivers UK Chapter events, as long as they comply with the following:

- They have made their guests known to the event organisers.
- They and their guests have signed this disclaimer.
- They agree to be responsible for their guests at all times.
- They ensure that their guests have fun, but conduct themselves in an appropriate manner befitting of a family-orientated organisation at all times.
- Where a guest is also riding it is the members' responsibility to ensure that their guest understands the Chapter's riding policy, and asks the guest to spend a few minutes with a Road Captain. The Road Captain will go through the riding policy and then ask the guest to sign this disclaimer. If they do not sign this disclaimer and agree to abide by the riding policy then they will not be able to ride with the Chapter.

A riding guest should, in normal circumstances, be limited to 3 rides per season. If they want to ride more than 3 times with the Chapter then they should be asked to become a member in their own right.

Guests' attendance at riding events will be recorded by the Road Captain leading the ride and reviewed on a monthly basis by the Head Road Captain.

The information you provide in this form will be used solely for dealing with you as a member of the III Rivers UK Chapter ("The Chapter"). The Chapter has a Data Privacy Policy which can be found at www.iiirivershogchapter.co.uk.

Your data will be stored and used in accordance with this Policy. By signing this form you are consenting to The Chapter to collect this data, store it and process it only for the purpose of running The Chapter and keeping a record of your participation as a guest. Photographs or videos may be taken at ride outs or events organised by The Chapter and those published on our website or social media channels to promote The Chapter. By participating in these ride outs or events you will be consenting to your image being used by The Chapter in this way.
